





- Quickness and flexibility are considered priority attributes in the response to the needs of our clients, either in standard reinsurance products or specialized tailor-made solution.




 After more than 80 years from its start, Nacional Re has reached and maintained a relevant leadership in the Spanish market.

• Around 30% of the portfolio comes from outside Spain, mainly Europe.


# Our portfolio reflects a strong competitive position




### **Net Combined Ratio**





#### **Investment Portfolio 2022**




#### Solid and consistent results before tax
